In consideration of the publication of your Contribution, the Editors ask you ('the Author') to agree to the following terms:

Copyright Assignment:

- (i) Authors retain copyright of their submitted work and grant *Aparðjón* right of first publication of the work. The submission will be licensed under a Creative Commons Attribution License which allows others to share the work, crediting the work's authorship and the initial publication in *Aparðjón*.
- (ii) After their work is published in *Aparðjón*, the Author is able to enter into separate contractual arrangements for the non-exclusive distribution of the journal's published version of their work, with acknowledgement of its initial publication in *Aparðjón*.
- (iii) After the submission and publication process with *Aparðjón*, the Author is permitted and encouraged to post their work online (e.g., in institutional repositories or on their website).

Confirmations and Indemnifications:

- (i) The Author confirms that the contribution is their own, original work, and contain no plagiarised material.

- (ii) The Author confirms that the contribution is not currently in consideration for publication elsewhere.
- (iii) The Author confirms that the contribution has not been published previously (in whole or in significant part) elsewhere.
- (iv) The Author confirms that they have obtained, or will obtain, all necessary permissions from relevant copyright holders to reproduce or quote any material from other copyright sources contained in this work, including illustrations and audio-visual material. These permissions must cover the electronic distribution of the contribution. These permissions are to be obtained by the Author, at their own expense, from the copyright owner and are to be provided to the Editors in addition to the Author's submitted contribution.
- (v) The Author confirms that they indemnify *Aparðjón* against any claims for breach of these above confirmations.

Submissions that do not adhere to these Confirmations and Indemnifications will be returned to the Author and will be refused consideration for publication.

Requirements for Publication:

Authors agree to prepare and revise their contribution according to the instructions of the Editors and to meet all other requirements for publication communicated to the Author by the Editors. If the Author is unable to make suitable corrections in a timely manner, *Aparðjón* holds the right to not publish their work.

Please complete, sign, and date this agreement, and return it to the Editors via email, retaining a copy for your files. In signing the Author agree that the electronic signature shall be valid and binding for all purposes, and hereby waive any objection to use of an electronic version of this agreement as a substitute for the original for any legally recognised purpose. *All joint authors must sign, each on a separate form if necessary.*
