UNIVERSITY OF ABERDEEN SENATE BUSINESS COMMITTEE (29 April 2020)

Under Senate Standing Order #2 we the proposer and seconders call an emergency meeting of Senate for the week of 27 April to debate and vote on the following resolution:

Senate recognizes and acknowledges the tense situation surrounding the Covid19 Pandemic, and in particular, the quick and understandable decision to close the campus. Senate also recognizes and appreciates the work of those still maintaining and securing the campus, and those conducting laboratory research which could not be interrupted.

Acknowledging that Senate voted (by 45 of 133 votes) to temporarily devolve its authority to the office of the VP Education, we have noted the following:

- It is understandable that quick decisions had to be made, but it has now become clear that this is not a temporary situation and therefore we will have to return to a normal model of oversight.
- The decisions now being circulated involve multi-year changes to how teaching is delivered, and how degrees are calculated, and so lies outwith the remit of the original devolution of authority;
- That the recent proposal to shift all teaching online for HS1 (2020-21) has not been buttressed with guarantees to intellectual property, appropriate workload, or access to "business critical" teaching materials locked up on campus
- That consultation has been confined to the Senate Business Committee SBC, Senate Assessors, and/or ex officio Heads of School (and in an ad hoc way across Schools);
- The Senior Management Team have overturned a Senate decision on the rounding of grades;

We therefore resolve that:

- 1) We revoke the emergency powers devolved to the VP Education with immediate effect;
- We request striking a formal Covid19 Emergency Committee to design a new forum for Senate to meet and vote, and to coordinate communication between Senate, SMT, and constituents;
- 3) We request that the proposed Emergency Committee have representation of elected senators from all schools, and that any proposals it makes are subject to mandatory consultation with academic staff.
- 4) We call on the VP Education to report back to the next full meeting of senate on all decisions taken on Senate's behalf;
- 5) We suggest that Senate will need to meet more often than is presently anticipated in the Standing Orders to shape the form of the next academic year;
- 6) We ask that the Principal report to the next Senate an outline for the phased or partial reopening of campus
