Study details	
ECTS Credit	Students typically take 30 ECTS per semester at Trinity and cannot exceed this amount. Modules usually have a 5, 10 or 15 ECTS value. Students must take a minimum of 20 ECTS in a semester and 45 ECTS for the academic year.
Host department	Students must take at least 50% of their ECTS per semester in their host department (as specified in the terms of the IIA and in the student's offer letter). Students can request to enrol in modules offered by other departments for the remaining ECTS. There are some exceptions to this rule. E.g., Languages

Insurance

Students arriving from outside the EU/EEA, Switzerland and the UK should contact their health insurance provider to determine if they are covered while studying abroad. If not, students will need to arrange health insurance prior to departure, or purchase insurance locally in Ireland.

Health insurance cover is mandatory for those who are required to register with the Irish Naturalisation and Immigration Service (INIS).
