Login to MyHR

- 1. On a University networked device, open a web browser and go to www.abdn.ac.uk/myhr
 - Off campus, or on a personal device? You must first log into the VPN. See our Toolkit resource for guidance on using the VPN. Once logged into the VPN, you will see a link to MyHR under the Home tab. Click on this then follow the steps below.
- 2. You'll see the MyHR Welcome screen the login dialog, latest news, and links to other resources.

My Details

When you login to MyHR, you will see your personalised Welcome dashboard, to update your details expand the My Details menu on the left-hand column.



- 1. The IMPORTANT INFO section provides some background and outlines scenarios where details may not be able to be updated online and offers available alternatives.
- 2. The My Information section allows you to review, update and add the following information:



- Personal Information some information may have been captured as part of your recruitment process but there will be the option to amend and add additional information not previously collected.
- b. Contact Information you can add and update your home address and contact details here.
- c. Emergency Information you can add and update your emerency contact and next of Kin information here.
- d. HESA Person Details you can disclose if you are a British Sign Language User and view your HESA and, if applicable, your ORCID IDs. If yu think these need updating please contact the <u>MyHR team</u> with the required information.
- e. Bank Information you can add and update your bank information here. This is where your salary wil be paid into. If you are a new starter this section will be empty and should be added at the earliest opportunity.
- f. Complete once all information is completed you will be able to submit your updates, unless one of the conditions identified in the important information section is met. Once you submit your information you wil receive a conformation email to your work email address.

Mandatory information is demoted by * and full guidance is available on screen for each of the above sections.
