472. Minutes

472.1 With a minor amendment the Committee approved the minutes of the meeting held on 29 April 2020.

473. Draft Agenda for the meeting of the Senate on 18 June 2020

- 473.1 The Committee noted that there would be an update on the Covid response, but that this would not be as extensive as the coverage at the last meeting of Senate.
- 473.2 Regarding the planned update for Senate on the KPIs for Aberdeen 2040, the Committee noted that these had been put out to the University community for consultation through the staff eZine. Discussion at Senate was intended to centre on prioritisation of the KPIs.
- 473.3 The Committee noted that the item on Governance for Trans-National Education (TNE) would be led by Richard Wells. The paper to be considered at Senate would also be included for consideration at the Policy and Resources Committee, before being submitted to Court.
- 473.4 The Committee queried the relationship between the planned document on TNE governance and the previously Senate approved procedures. It was confirmed that those procedures were being incorporated within the proposed governance structure,
- 473.5 It was noted that it was not anticipated that there would be anything significant in terms of a REF update available in time for the scheduled Senate meeting

4. Purpose

This would not preclude such topics being included on the agenda *ad hoc* in response to, in particular, national consultations and major issues that emerged during the course of an academic year that the University should address.

The Senate Business Committee, in drafting Senate agendas, should also decide, as deemed appropriate whether an external speaker (e.g. from the Scottish Funding Council, the Scottish Executive, Universities Scotland, the Higher Education Academy) should be invited to address the Senate on a topic of current interest or debate within the HE sector.

The Senate Business Committee is also asked to determine the timing of consideration, by the Senate, of annual reports from the Senior Vice-Principal, the central Vice-Principals and the University Secretary.
